Once you have been accepted in the lottery, you will be asked to submit a \$50 deposit and complete an income verification form. If you choose not to submit an income verification form, your tuition will be between \$3,492 and \$4,284 - based on family size.

Tuition will be due 10 equal monthly payments, with the first payment due on August 1, 2018 and the last payment due on May 1, 2019. Non-payment of tuition will result in dismissal of the student from the PreK program.

These tuitions are consistent with State of CT regulations as of 11/17/2017 and are subject to change as State of CT regulations change.

Definition of Household Income

Household income includes income for employment, self employment income

Income excluded includes:

- TFA Cash Assistance
- Child support payments
- Earned income credit payment
- Cash contributions from non-profit charitable organizations
- Income tax refunds
- Grants, loans and scholarships paid to students
- State or federal government rental subsidies
